Requested Agenda Item: Water Meters and Cellular Endpoints Sole Source Purchase

Description of Requested Agenda Item: Salisbury-Rowan Utilities (SRU) is projecting a need for increased inventory of 5/8" x 3/4" water meters and cellular endpoints based on the current number of developments that are approved or proposed throughout the SRU service area in Rowan County. Due to the expected delivery time of 3-4 months, SRU is requesting to initiate a large order in an effort to meet the expected demand for water meters over the coming months. SRU is requesting a sole source purchase of the quoted water meters and endpoints due to standardization of equipment. Attached is the quote from Badger Meter.

North Carolina General Statute 143-129(e)(6) allows for "Purchases of apparatus, supplies, materials, or equipment when: (i) performance or price competition for a product are not available; (ii) a needed product is available from only one source of supply; or (iii) standardization or compatibility is the overriding consideration. Notwithstanding any other provision of this section, the governing board of a political subdivision of the State shall approve the purchases listed in the preceding sentence prior to the award of the contract."
