Proposed Project:

- Remove back decks and install 12' by 20' rear porch with EPDM roof, craftsman styled columns, metal railings, and composite tongue and groove flooring
- Install 12' by 16' back deck with metal railings
- Install round brick patio

Proposed Project:

- Exterior renovations to create three residential units, no changes to front elevation
- Create stair penthouse on roof and add metal guardrail on rear elevation
- Create upper story deck with metal guardrails and columns and transition middle window to door; transition bricked in window to door and replace windows with aluminum clad windows on back elevation

- Exterior renovations to create eight residential units and two commercial units, no changes to front elevation

- Install two decks with metal handrails and two patios on rear elevation
